The award established by this Deed of Gift shall be known as the David Poe Memorial Yachting Service Award

This award is named in honor of David Poe, co-founder and publisher of SANTANA and H²O magazines, in memory of his tireless efforts and outstanding service to the boating community before his death on January 10, 1994. David Poe was chosen the first recipient of this award.

1. Purpose.

The award may be presented annually by the Association of Santa Monica Bay Yacht Clubs ("ASMBYC") to recognize individuals or organizations (such as business firms, boating groups, or governmental bodies) for outstanding service to yachting in areas other than as an active boater. To preserve the integrity, prestige and significance of the award, the award is intended for just one individual or organization per year. In unusual circumstances, this award may be given to more than one recipient in a single year.

2. Qualifications

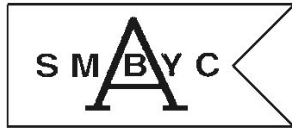
It is the intent of this deed to elect nominees for, but not limited to, service in teaching, youth work, charity efforts, promotion of yachting, race management, or any similar contributions of time and/or talent to yachting beyond the recipient's normal obligation.

The services being recognized need not have been accomplished in the year of the award. Candidates who have performed services to yachting over a sustained period shall be considered. The record of service need not be performed or executed in Santa Monica Bay, although a relationship between the recipient and the ASMBYC area should exist. The recipient need not be affiliated with a Regular/Associate Member ("Member") of ASMBYC, and there shall be no geographical limitations.

3. Nomination/Selection Processes

The nomination and selection processes used for the Yachtsman of the Year will be used for the recipient of this award.

Full and complete nominations must be received by the Vice Commodore of ASMBYC on or before **October 1** of each year.

4. Perpetual Trophy

This award shall consist of a perpetual trophy which shall be displayed at an ASMBYC-member club of the recipient's choice during the year they are so honored. If there is more than one recipient in a given year, they may share possession of the award equally. An appropriate take-home award shall be contributed by ASMBYC and presented to the recipient(s).

5. Presentation

This award is to be presented at the annual ASMBYC Installation Dinner.

6. Amendments

Full authority over the Trophy and the Deed of Gift is hereby granted in perpetuity to the ASMBYC Board of Directors. Amendments to the Deed of Gift shall be designed to carry out the intent of the deed and shall be made by a two-thirds majority vote of the ASMBYC delegates at a regularly scheduled ASMBYC meeting. Written notice of said amendment shall be delivered or mailed to each Member 30 days prior to said meeting.

In the event the ASMBYC organization ceases to exist or operate, ASMBYC member Santa Monica Windjammers' Yacht Club shall succeed to all rights of the donee.
