DEED OF GIFT ASMBYC COMPETITIVE YACHTING ACHIEVEMENT AWARD

The Competitive Yachting Achievement Trophy is to be presented as hereinafter set forth:

1. Purpose

The Competitive Yachting Achievement Trophy recognizes a senior yachtsman or team who has distinguished him or herself, or itself in competitive yacht racing on a regional, national or international level. This Award is different from other awards in that it emphasizes competition away from home shores and may be in either, sail, power, or self propelled craft.

2. Qualifications

A nominee must have had and affiliation with but need not be a member of an ASMBYC Regular or Associate Member ("Member") in good standing.

Full and complete nominations shall be in writing, signed by the Commodore or Commodore's designee of the nominating Member and shall include sufficient information about the nominee to assist the Selection Committee. The nominations must be received by the Vice Commodore of ASMBYC on or before October 1 of each year as evidenced by dated email sent to the official Vice Commodore's email address or received in the ASMBYC mailbox.

The award shall be made to a person for outstanding achievement in major regattas or events held outside of Santa Monica Bay, especially national and international competition.

The award is to be made for recent achievement within the last five (5) years.

3. Nomination Process

Each ASMBYC Member shall have the right to nominate one yachtsman or yachtsmen team for the Award.

Nomination process proscribed in the Deed for Senior Yachtsman of the Year shall be used for this Award.

4. The Selection Committee

The selection process proscribed in the Deed for Senior Yachtsman of the Year shall be used for this Award.

5. Perpetual Trophy

The Competitive Yachting Achievement Award Trophy is a perpetual trophy which shall be displayed at the ASMBYC-member club of the recipient's choice until his or her successor recipient is named. The Trophy remains the property of ASMBYC which shall have the sole right to determine its disposition. The recipient of the Trophy shall also receive an appropriate take-home award.

6. Presentation

This award is to be presented at the annual ASMBYC Installation of Officers and Award meeting.

7. Additional Provisions

Each recipient shall execute an ASMBYC Receipt and Agreement. A photocopy of Perpetual Trophy is attached.

8. Amendments

This Deed of Gift may be amended by the method proscribed in the Deed for Senior Yachtsman of the year.
