The award established by this Deed of Gift shall be known as the Diane Armstrong Memorial perpetual Trophy. This award is so-named in honor of Diane Armstrong a long time, enthusiastic and hard working member of the Santa Monica Bay yachting community. Diane believed that sailing was a sport that was enjoyed in many ways and enhanced youth development of competition, camaraderie and sportsmanship. Diane was an advocate of junior sailing both on a regional and national level.

Purpose: The award shall be presented annually to recognize a youth in each of the various ASMBYC member clubs that sponsor a junior program. The awardees should be juniors that best depict the qualities of competition, camaraderie and sportsmanship within a yacht clubs individual program. They should either be or potentially be active racers on a regional and national level.

Description: (A nice trophy)

Award: Each ASMBYC member yacht club will submit a name of a member of their youth program that in their opinion best fulfills the purpose of this award. The Association's Secretary must receive the nomination by the date that coincides with the submission date for nominations of the Junior Sportsman and Junior Yachtsman of the Year. The same age guidelines for the Junior Sportsman and Junior Yachtsman will apply. The award will go to all submitted candidates. The custodianship of the Perpetual Trophy will rotate on an annual basis between the clubs represented on the trophy.

Presentation: Each winner of the award will have their name inscribed on the trophy and alphabetically arranged by last name. The name or acronym of the nominating yacht club will follow the nominee's name. The trophy will be presented to all honorees at the ASMBYC Installation and Trophy Presentation Ceremony. Any ASMBYC member club wishing to recognize its recipient of this award with a separate 'take home' trophy is encouraged to do so.

Amendments: Full authority over the Trophy and the Deed of Gift is granted to the Association of Santa Monica Bay Yacht Club Board of Directors. Amendments to the Deed of Gift shall be designed to carry out the intent of the deed and shall be made by two-thirds majority vote of the Association of Santa Monica Bay Yacht Clubs Board of Directors made at a regularly scheduled ASMBYC meeting. Written notice of said amendment must be mailed to each member of the board 30 days prior to said meeting.

In the event the Association of Santa Monica Bay Yacht Clubs shall cease to exist or operate, the trophy shall reside with the California Yacht Club.
